- 02. Buses are fully covered under Government norms laid by the Transport Department and vehicle on the road shall all times carry the following valid documents (in original) and shall be produced on demand by officer empowered to demand documents by or under the Motor Vehicle Act 1988 alongwith documents shown in E. Parivahan Portal whevever required.
  - (a) Certificate of Registration.
  - (b) Certificate of Fitness.
  - (c) Certificate of Insurance.
  - (d) Taxation Certificate (Tax Token)
  - (e) Permit granted by the Regional Transport Officer.
  - (f) Pollution Under Control Certificate
  - (g) Heavy Driving Licence of Driver with Badge.
  - (h) AADHAR of Driver and Khalasi.
- Hire Charges will be paid to the Transporter by Account Payee Cheque after deducting TDS as per 03. Income Tax rule, Government of India.
- Transporter will be responsible to deduct PF and ESIC contribution and also liable to Police and Road 04. accident litigation etc.
- Diesel will be provided by the Transporter as per the running average mentioned in the agreement 05. and school will pay the bill of fuel alongwith monthly hire charge.
- In case of break-down of the Bus, alternative arrangement will be made by the Transporter. 06.
- Agreement will be applicable for 11 months w.e.f. 04.04.2025 to 28.02.2026. 07.
